



# **TERMS OF USE**

#### **TERMS AND CONDITIONS**

The Industrial Energy Efficiency Program application portal (the "IEEP Portal") is owned and operated by the Independent Electricity System Operator (the "IESO") for the purpose of administering the Save on Energy Industrial Energy Efficiency Program (the "IEEP"). Only an applicant, participant or the representative of an applicant or participant (each "you" in the context of these Terms of Use) may access the IEEP Portal to apply for a IEEP incentive and manage the application throughout the process. Please carefully review the terms and conditions that govern your use of the IEEP Portal periodically as they are subject to change. By signing up for a IEEP Portal account and using the IEEP Portal you agree to follow and be bound by the terms and conditions of these Terms of Use. You also agree to bind any company or organization on behalf of whom you are accessing the IEEP Portal. If you do not agree to these Terms of Use, do not use the IEEP Portal or download, access or use any materials from it. The IESO may change these Terms of Use at any time and without notice. Any changes will be effective immediately upon posting or as otherwise indicated. Your use of the IEEP Portal following any such change constitutes your agreement to follow and be bound by the Terms of Use, as changed.

## **ACCEPTABLE USE**

You agree to use and access the IEEP Portal only in accordance with these Terms of Use, applicable law, the IEEP Requirements posted on the Save on Energy website

## SUSPENSION OR TERMINATION OF ACCOUNT

You agree that the IESO, in its discretion, for the purpose of emergency maintenance or reasons related to suspected security breaches, fraud or unauthorized access or misuse, including a breach of these Terms of Use, may suspend or terminate your access to any portion of the IEEP Portal, without prior written notice to you. The IESO may also suspend or terminate your access to any portion of the IEEP Portal in its discretion, without prior written notice to you, if the IESO reasonably believes you have or are suspected to have engaged in fraudulent or negligent activities or willful misconduct while participating in or providing services for the IEEP. In the event of suspension or termination, you will no longer be authorized to access or use the IEEP Portal and the IESO may take actions against you to ensure such access or use ceases.
