#### Terms and Conditions

The Applicant has applied for a Training and Support incentive ("Incentive"), pursuant to the Application submitted to the Independent Electricity System Operator ("IESO") for an IESO-recognized third party training and support initiative (the "Initiative").

THE IESO RESERVES THE RIGHT, IN ITS SOLE DISCRETION, TO REJECT APPLICATIONS, OR CHANGE INITIATIVE RULES, FOR ANY REASON. ONLY APPLICATIONS THAT ARE COMPLETE AND MEET THE CRITERIA OUTLINED IN THE INCENTIVE AGREEMENT WILL BE CONSIDERED. THE TRAINING AND SUPPORT INCENTIVE IS AVAILABLE UNTIL DECEMBER 31, 2020 BUT MAY BE CANCELLED AT ANY TIME WITHOUT PRIOR NOTICE.

- 1. The Applicant confirms that no Incentive has been paid out to it or any Participant in respect of the Participant(s) for the Initiative(s) outlined in this Application.
- 2. The Applicant confirms that it or a Participant has paid the invoice(s) attached to this Application for the Initiative(s) in full.
- 3. The Applicant confirms that this Application is submitted within eight (8) months of the Participant(s) completing the Initiative(s).
- 4. The Applicant confirms that any and all Participants were employed by, or are members of, the Applicant at time of Initiative participation, and continue to be full-time employees and/or members as of the date of Application submission.
- 5. The Applicant and Participant(s) each confirm that they are either a resident of Ontario and/or operating in Ontario or conducting business in Ontario.
- 6. Applicant and Participant(s) each confirm that all of the eligibility requirements for each Initiative selected have been met.
- 7. If the IESO approves the Application, the IESO will, subject to the terms and conditions of this Agreement and the Application, pay to the Applicant an Incentive for the Initiative(s) selected in the Application according to the Incentive amount up to the maximum limit in effect at the time of the Application submission.
- 8. The Applicant and the Participant(s) agree that each may share information with the IESO required to verify this Application, and the IESO may contact the Applicant or Participant(s) to conduct interviews, surveys or audits for the purposes of Initiative evaluation, verification, measurement or management.
- 9. The Applicant and the Participant(s) understand and agree that by submitting the Application, whether or not this Application is accepted: (a) each hereby consents to the collection, use, disclosure and other handling of any information it provides to the IESO, including personal information and records pursuant to the Freedom of Information and Protection Act (the "Information") relating to the operation, administration or assessment of the Initiative or the Application or the Agreement, and in connection with any reporting activities relating to the Initiative, which shall include, without limitation: (i) sharing of Information with Initiative evaluation consultants, service providers and training and support service providers; (ii) use by these parties of the Information to conduct, analyze and report on the results of surveys and modify the Initiative based on such surveys; and (iii) disclosure to the Ontario Energy Board, the Ontario Energy of the Ontario Environmental Commissioner or their respective successors; (b) each hereby consents to the disclosure by the IESO to local distribution companies of information regarding the Applicant or Participant's past participation in other IESO-funded conservation and demand management programs for the purpose of processing the Initiative evaluation; and (c) each will indemnify and save harmless the IESO, Union Gas Limited, Enbridge Gas Distribution Inc., its service providers and its respective directors, officers and employees from any and all liability and all claims, losses, damages (including indirect or consequential damages), expenses and proceedings for personal injury (including death) or property damage of any person relating to, in connection with, resulting from, or arising out of the Initiative.
- 10. The Applicant and the Participant(s) understand that in connection with surveys, studies, audits and promotions of Save on Energy-related initiatives, the IESO may contact them directly. The Applicant and the Participant(s) also consent to the IESO contacting them including by email and other electronic communication for purposes of follow-up surveys, studies and audits, future conservation programs, customer satisfaction surveys, and other related purposes and understand that they may withdraw this consent at any time by contacting the IESO at 120 Adelaide Street West, Suite 1600, Toronto, ON M5H 1T1 or efficiency.training@ieso.ca.
- 11. Except as otherwise provided, the terms and conditions as outlined in this Agreement and the Application constitute the entire agreement between the parties in connection with its subject matter and supersede all prior representations, communications, negotiations and understandings, whether oral, written, express or implied, concerning the subject matter of this Agreement. This Agreement may not be varied, amended or supplemented except by an agreement executed by all of the applicable parties. Each of the parties will, from time to time, on written request of the other party, do all such further acts and execute and deliver or cause to be done, executed and delivered all such further things as may be reasonably required in order to fully perform and to more effectively implement the terms of this Agreement. This Agreement will be governed by and construed in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein. The invalidity, unenforceability or illegality of any provision in this Agreement will not, to the extent permitted by applicable laws, affect the validity, enforceability or legality of any other provision of this Agreement, which will remain in full force and effect.
- 12. Each party to this Agreement will comply, in all material respects, with all laws and regulations required to be complied with in the performance of its obligations hereunder.
- 13. The Applicant and the Participant(s) understand and agree that non-compliance with the terms and conditions of the Agreement may result in revocation of Incentive amounts.

For Save on Energy/Union Gas or Save on Energy/Enbridge Joint Incentives only:

In addition to the above Terms and Conditions, the following Terms and Conditions apply for the Save on Energy/Union Gas and/or Save on Energy/Enbridge ("Joint Incentives"):

- 1. The Applicant must have an active Union Gas Limited ("Union Gas") business account in good standing or an active Enbridge Gas Distribution Inc. ("Enbridge") account in good standing.
- 2. If the IESO approves the Application, Union Gas or Enbridge will, subject to the terms and conditions of this Agreement and Application, and within 90 business days, pay directly to the Applicant an Incentive for the Initiative(s) selected in the Application up to or equal to 30% of course fees up to a maximum limit of (i) \$200 per day for Dollars to \$ense, (ii) \$750 for Building Operator Certification, and (iii) \$900 for Certified Energy Manager.
- 3. If the IESO approves the Application, the IESO will, subject to the terms and conditions of this Agreement and the Application, and within 90 business days, pay to the Applicant an Incentive for the Initiative(s) selected in the Application up to or equal to 45% of course fees up to a maximum limit of (i) \$300 per day for Dollars to \$ense, (ii) \$1600 for Building Operator Certification, and (iii) \$1600 for Certified Energy Manager.
- 4. The Applicant consents to the IESO sharing Applicant information with Union Gas or Enbridge for the purposes of confirming the Union Gas or Enbridge account, submitting payment to the Applicant address, and contacting the Applicant in connection to the foregoing.
- 5. The Save on Energy/Union Gas Joint Incentive only applies for courses taken after January 1, 2018.
- 6. The Save on Energy/Enbridge Joint Incentive only applies for courses taken after April 6, 2018.
- 7. Union Gas or Enbridge reserves the right to reject an application for any reason.
